(A Resolution updating, revising, and amending various Resolutions)

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF ST. JOSEPH, INDIANA, UPDATING, REVISING, AND MAKING GENERAL HOUSEKEEPING CHANGES TO VARIOUS EXISTING RESOLUTIONS AND PLANS ADOPTED BY THIS BOARD

WHEREAS, the federal government enacted Title VI of the Civil Rights Act of 1964, as amended, to prevent discrimination on the grounds of race, color, sex, age, disability or national origin and to ensure that individuals are not excluded from participation in, denied benefits of, or otherwise subjected to discrimination under any program or activity receiving federal financial assistance on the basis of race, color, sex, age, disability or national origin;

WHEREAS, it is a requirement of the Indiana Department of Transportation (INDOT) and the United States Department of Transportation that communities receiving federal financial assistance adopt a Title VI Program, Implementation Plan, a Limited English Proficiency Plan, and an Environmental Justice Policy;

WHEREAS, in the interest of economic development and customer service, the Board has determined that the County should make use of social media in order to disseminate information from the County about the County's mission, meetings, activities, and current issues to members of the public; and

WHEREAS, from time to time, employees of the county, job descriptions, and job titles are subject to change and it is in the public's interest that plans are updated accordingly to reflect these changes;

NOW, THEREFORE, BE IT RESOLVED BY THE ST. JOSEPH COUNTY BOARD OF COMMISSIONERS, THAT:

Section 1. 

Section 4. This Resolution shall be in full force and effect upon its passage.


